**Description** Research is a necessary undertaking toward the continued development of nursing science, research and practice. Nursing Honours Thesis in the full time mode is a 60 Credit Point (CP) subject comprised of Nursing Honours Thesis A FT (20 CP) which is a Multi Term (MTS) continuing subject to Nursing Honours Thesis B FT (40 CP). The subject provides an opportunity for students under the guidance of their academic supervisors to propose, plan and implement a research project related to nursing, and work towards planning, developing and producing a written thesis due to be completed and submitted for examination in this subject, Nursing Honours Thesis B FT.

## **Subject Content**

Students are required to engage in scholarly work consistent with the expectation of an Honours program. Completion of an Honours degree requires the ability to be able to complete the compulsory significant

research component, namely a written honours thesis of 15,000-20,000 words within a set time frame.
