Description Company accounting introduces and develops a student's understanding of the Australian reporting requirements and practices relating to corporations. The subject builds upon the fundamental accounting skills gained in Introductory Accounting to develop a student's knowledge of technical methods and theoretical underpinnings of corporate accounting. Students will learn how to prepare consolidated financial statements, with associated disclosures, to ensure compliance with accounting standards, corporations' legislation and Australian Stock Exchange (ASX) requirements. Through a range of practical individual and collaborative means students will explore corporate accountability and the reasons for regulatory disclosure.

Subject Content

1. Accounting standards (standard settlers, regulation and application).
2. Cash flow statements.
3. Tax effect accounting.
4. Accounting for non-current assets including impairment and revaluations, including changes in accounting estimates and errors, and events after reporting period.
5. Consolidations for wholly owned entities.
6. Accounting for Financial instruments and relevant disclosures.
7. Introduction to accounting for foreign currency translations.
