Description The subject provides an overview of the ideal ethical standards for construction services incorporating the concept of trustworthiness as the only reliable indicator of ethical building and design practices. Students explore ethical challenges in the quality assurance mechanisms for building materials and components and reflect on their professional practice that contributes to the protection of end-users through trustworthy buildings.
