Description This subject will focus on the fundamental skills and theory of mediation, specifically in the context of the Australian legal system. It builds upon the more general introduction given in the subject Alternative Dispute Resolution (which is a prerequisite for this subject). This subject is experientially based, and students will be expected to participate in discussions, exercises and role-plays. The theory and practice of mediation will be critically considered, as will the social and legal contexts within which mediation is practised. The subject is presented with a multi-disciplinary, analytical and practical approach, including the perspectives of First Nations peoples. It will focus on mediation in different legal contexts such as commercial litigation, employment law and family law. Issues of culture, power, mediator neutrality and ethical dilemmas for the mediator will be considered. This subject is intended to be an introduction to the practice of mediation.
