Restrictions

To enrol in this subject, students must have successfully completed 80 credit points of law subjects.

The subject will not be available for self-select enrolment. Intake in the subject will be restricted to expressions of interest. GPA and progression in the program will be considered, and the pre-requisites must be met.

 - Comparing different legal systems in a global context.
 - Assessing the strengths and weaknesses of various legal traditions and their impact on global legal frameworks.
- Cultural Influences on Law and Governance:
 - Understanding how culture shapes legal and governance practices.
 - Exploring the role of cultural norms, values, and customs in legal decision-making processes.
- Impact of Globalisation on Law and Society:
 - Investigating the social and justice implications of globalisation.
 - Examining the challenges and opportunities presented by globalised legal systems.
- Intercultural Competency and Professional Skills:
 - Developing intercultural competency skills to effectively engage with diverse individuals and communities and their legal systems.
 - Enhancing professional skills required to navigate a globalised legal profession.
