Description Humans have always used psychoactive substances, and this interdisciplinary subject critically examines the evolving landscape of regulating this practice. It examines the historical aspects of drug use and prohibition, analyses the characteristics of different psychoactive substances, and explains and evaluates international and domestic drug laws and their effects. The subject also addresses contemporary issues such as harm reduction, pill testing, safe supply, safe consumption rooms and drug decriminalisation and legalisation. The subject examines the dynamic domestic and international legal frameworks surrounding cannabis and psychedelics, reflecting on the future trajectory of drug laws. Drawing upon various disciplines, including legal theory, sociology, psychology, and public health, this subject prepares students for advanced research, policy analysis, and roles in law-making, law enforcement, and drug-policy NGOs.
