

# LAWS 7073 ANIMAL LAW

**Description** This subject examines the legal and ethical relations between humans and non-human animals. Students will apply theoretical perspectives to support their own stance regarding human/animal relations. They will critically evaluate the legal framework which governs those relations. The subject will examine a range of topic such as the moral and legal status of animals, animal rights versus animal welfare, farming and husbandry practices, animals in scientific research, animals in the entertainment industry, wildlife protection and endangered species, companion animals and Indigenous approaches to animal welfare. Students will engage in professional learning activities and use a range of legal research tools to demonstrate their application of this body of law in practice.
