## Work integrated learning

Each student will have an accredited cardiac sonographer as a clinical supervisor at their training site. The clinical supervisor will be provided with numerous means of support by WSU, including:

- An email at the commencement of the program from the program coordinator to verify support for the student and to ensure the supervisor that they can contact the coordinator at any time.
- Information about subject content each semester via email: 1.

Learning Objectives - sent at the start of the semester, and 2. Practical assessment details - sent at the mid-point of the semester.

- A Zoom meeting in week 3 of the first semester where clinical supervisor recommendations are given (along with the opportunity for Q and A).

## Special Requirements

Legislative pre-requisites

Legislative requirements (such as a criminal record check) are not deemed necessary for students in the ultrasonography course. For students who complete their clinical training in a NSW public hospital, the necessary legislative requirements will be part of their employment conditions. Clinical training for many of the students will be in a private setting, where the necessary requirements (which are likely to differ from public institutions) will be addressed as needed. Training for some students will occur in locations other than NSW (where legislative requirements can be competed if, and when required).
